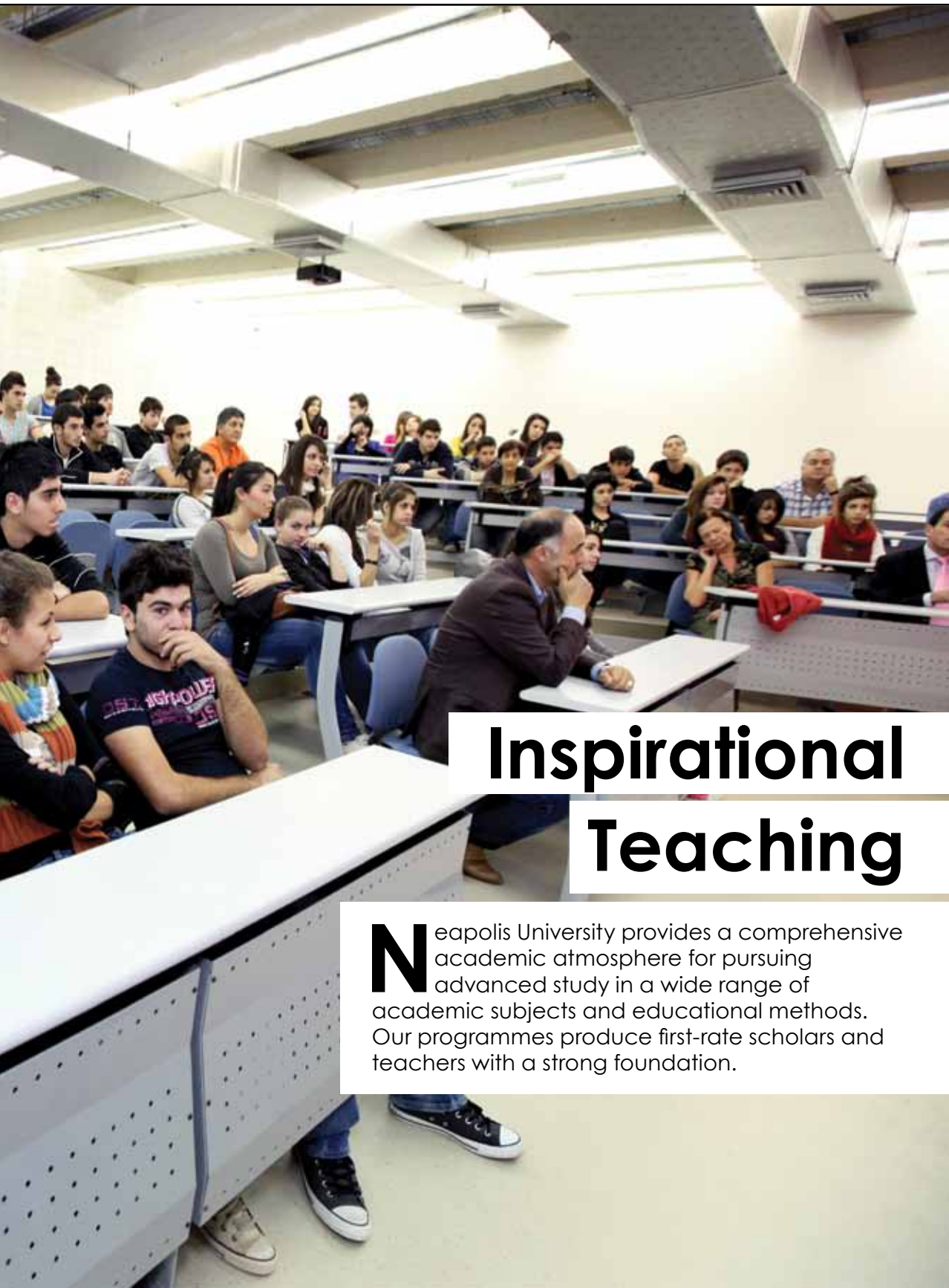
Academic Excellence

It belongs to the EU Life-Long Learning Program that invests in the creation and maintenance of a united European area for higher education. Erasmus managed to become a very successful program in promoting mobility and establishing strong institutional cooperation amongst European Universities. Our Erasmus office at Neapolis University Pafos is serving two ambitious aims to create a strong European network and offer the best services for Erasmus mobility for both incoming and outgoing members. Firstly, it aims to establish and maintain international relations and vital networks with European and International Higher Education Institutions. These relations can be materialized via Inter-Institutional agreements. Our office holds several important Inter-Institutional agreements.

Secondly, it serves Neapolis University Erasmus Charter. Therefore, our office welcomes and accommodates students, teachers and administrative staff coming from European Higher Educational Institutions.

If you register at Neapolis you will have the opportunity to participate in the Erasmus program. The Erasmus study period abroad will count towards your degree. 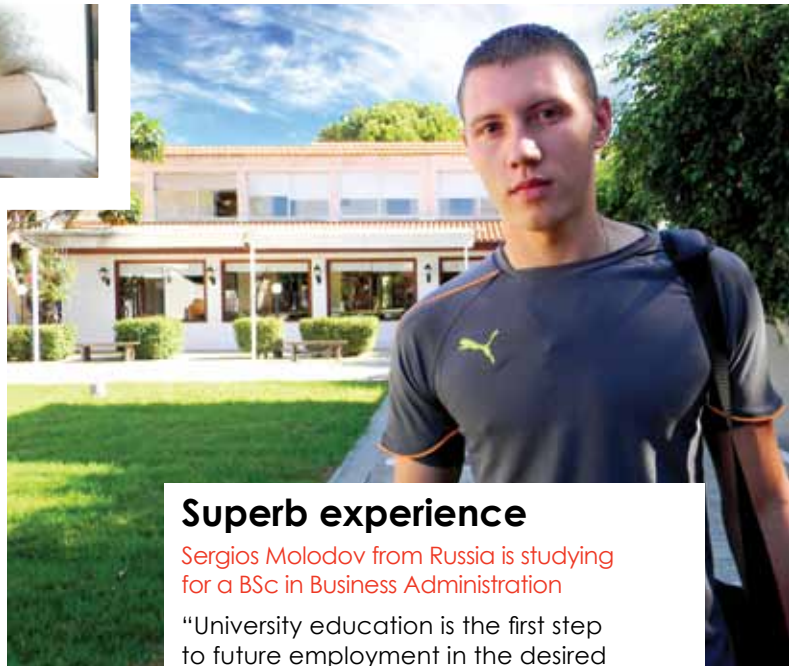

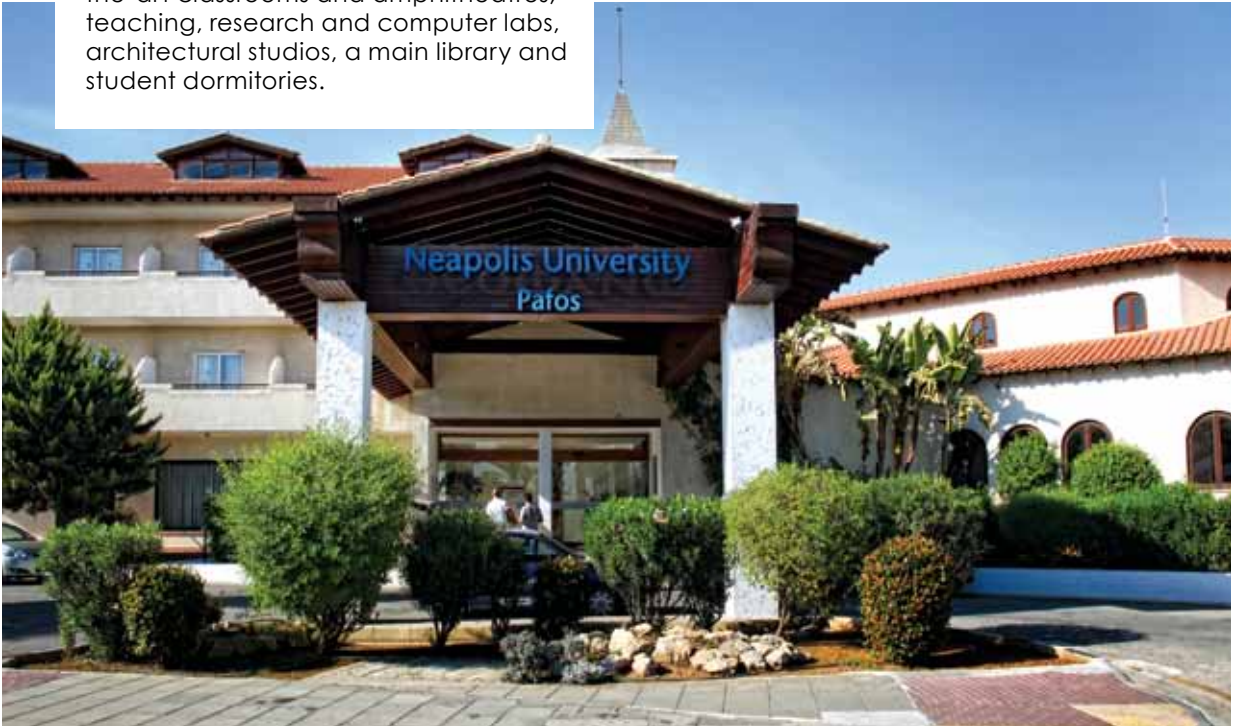
Student Life at NUP

Student life is a unique experience that the students themselves create during their studies at University. **Neapolis University welcomes and encourages the development of a diverse, multi-cultural and multi-lingual University community,** which respects diversity and enhances pluralism and the free exchange of ideas.

The unique location of the University campus, together with its modern premises and services form a unique environment which encourages knowledge, study and student life, offering to students the opportunity to enrich their experiences during their studies.

The University Campus

The campus of the University is a welcoming place for study and work at the heart of a vibrant town and just a hundred metres from the beach. The exceptional facilities and the services offered serve the diverse needs of our students and staff. They include state-of-the-art classrooms and amphitheatres, teaching, research and computer labs, architectural studios, a main library and student dormitories.





Student Societies

Through NUP Sports Clubs and Societies students get the opportunity to participate in various university sports events and tournaments. They are also offered the opportunity to take part in several sports events organised by the Municipality of Pafos, such as the International Beach Volley Tournament of the Municipality of Geroskipou, the Akama Marathon, the Cycling Race in Kouklia and the Amateur Swimming and Tennis Tournament of Pafos. The Climbing and Hiking Club organises various hiking, climbing and walking tours. NUP students can also take part in diving courses where they can explore Pafos coastline, the Akama district and the rich waterlife. The Theatre, Dance and Music Club aims to introduce students to Fine Arts during their studies.



Location

The University Campus, with its own student accommodation, located in the heart of the vibrant and world-heritage-designated city of Pafos, is a stone's throw from the city's beaches and its many attractions. The unique location of the University campus, together with its modern premises and services, form a unique educational environment for students to live an unforgettable experience during their studies.

Support

After registering with NUP all students are appointed a personal Academic Tutor who will provide them with continuous academic support towards completing successfully their studies. Concerning financial support students who have difficulties in funding their studies may visit the Course Office for further guidance. Each year a great number of students receive financial aid or scholarships from NUP.

Sports

The University campus offers a wide range of sports facilities: swimming pool, sauna, gym, tennis courts. Students are also eligible to use the sports centre and the playing fields of the Municipality of Geroskipou. Through NUP Sports Clubs and Societies students get the opportunity to participate in various university sports events and tournaments. They are also offered the opportunity to take part in several sports events organised by the Municipality of Pafos.

Cyprus

Cyprus is the third largest island in the Mediterranean Sea and one of its most popular tourist destinations. The island lies at the crossroads of three continents, where East meets West. Because of its strategic position the long history of the island has been marked by several invaders who have formed all together the political, economical, and cultural identity of Cyprus.

Many archaeological sites are protected by UNESCO as part of the World Heritage Site. Since 1974 Cyprus is under occupation (36% of its territory) after Turkey's invasion and the partition of the island. Nicosia remains the only divided capital in Europe. In 2008 the Republic of Cyprus became a member state of the European Union and joined the Eurozone.

Pafos, a Vibrant City

The university campus is located in Pafos, a city declared an UNESCO World Heritage Site whose history and culture stretches back into the depths of antiquity. Furthermore, it is a modern European multi-cultural city and a well-known international tourist destination. The presence of the remarkably rich historical past within the contemporary world, the combination of the mild Mediterranean climate, with the beautiful beaches and the well-preserved natural landscapes, as well as the vibrant and varied nightlife, the excellent transport links with other worldly

cities and the wide-range of services provided, establish Pafos as an ideal place to live and study.

Throughout the year, the city and overall the district of Pafos host numerous cultural, scientific and sports events, enabling young people to get involved actively in the community. In addition, the university's cultural, social, athletic and other student clubs frequently arrange extra curriculum activities and trips, in order for students to develop their own personal interests and hobbies.

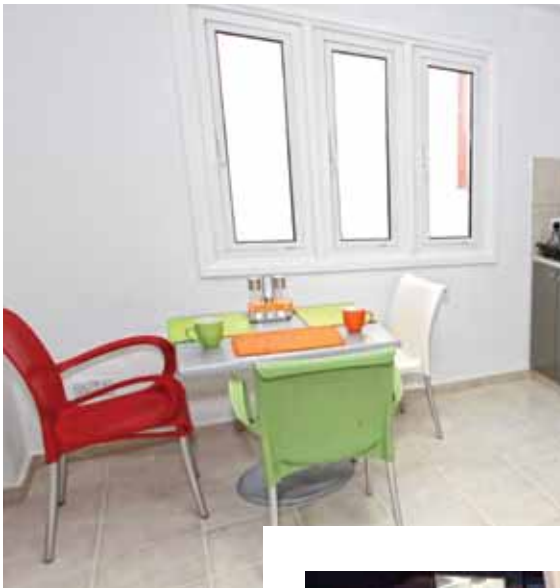

BSc IN BUSINESS ADMINISTRATION

The BSc in Business Administration at Neapolis University will enable you to develop a critical awareness of the main functional areas of Business Administration and the management process within a variety of organisations. It will develop innovative and intellectual problem-solving and communication skills and aid understanding of the business world.

With this degree you can be confident of being work-ready and armed with the skills required for professional and managerial roles in modern, global business environments. Core studies include accounting, economics, finance, management, marketing and law. A flexible course structure allows you to create a study programme that suits you and your career interests. Combine business administration studies with the business informatics or management degrees.

The main objective of the undergraduate Programme in Business Administration is to provide students with the knowledge and skills that are necessary for success in a fast changing, global business and economic environment. The Programme curriculum covers the basic disciplines of management and allows deeper treatment in human resources management, marketing and business strategy. The Programme uses a variety of pedagogical approaches to expose students to the problems they will face as managers, entrepreneurs and business leaders. The Programme places a high priority on the integration of theory and practice and complements its emphasis in teaching with an emphasis on research.

The Programme offers a number of elective modules that allow students to develop a deeper expertise in areas such as:

Tourism and Hospitality Business and Management, Management of Information Systems – Electronic Commerce, Marketing, Shipping Business and Management, Communications and Media Management, Insurance and Risk Management, International and European Business and Management, Sports Management.

Career prospects

Students who graduate from the course will have a solid understanding of the basic business disciplines as well as the economic, political, legal and environmental context in which the global practice of business is conducted.

Programme duration: 4 Years

SPECIALIZATIONS IN BUSINESS ADMINISTRATION

Tourism and Hospitality Business and Management

The Tourism and Hospitality Business and Management provides knowledge of immediate practical relevance and enhances both the analytic capabilities as well as the decision making of tourism professionals. Through a combination of taught modules, work placement or work-based learning, and dissertation students develop skills and knowledge which can be directly applied within the workplace. This specialization is designed especially for people wishing to further their career in the field of Tourism Management or aspiring to a leadership role in the industry. The programme aims to teach students professional, methodological, problem-solving, social and management skills.

Marketing

The main aim of this specialization is to introduce the students to concepts and principles relating to the basic elements of the management of marketing communications within an organization; furthermore, to help students to understand the importance of the skills, the approaches and the methods of communications used by organizations so as to achieve their business objectives. The students will be expected to understand policies and actions in the fields of advertising, public relations, sales promotion, integrated media and the brand development and brand support process within organizations.

Management of Information Systems – Electronic Commerce

The Management of Information Systems – Electronic Commerce specialization provides students with a general knowledge of business management while allowing each student to develop an understanding of selected aspects of electronic commerce. Students may choose to emphasize technical topics related to EC, marketing aspects of EC, or combinations of these or other business areas. Courses that students may elect to take cover the design and development of electronic commerce web sites, Internet marketing, electronic commerce project management, marketing strategy for electronic commerce, data communications, multimedia application development, and other business aspects of electronic commerce.

Shipping Business and Management

The specialization in Shipping Business and Management provides an overview of the complex world of the 'Maritime Industry' and the importance of the shipping industry in the global economy. The specialization uses facts highlighting the importance of shipping to the world of trade; Brief introduction to types of ships Geographical origins and destination of major cargo; Maritime Perils, Meteorology; Role of Broker, Charterers, Shipper, Carrier, Consignee, Distributor, Retailer and end-user; Contracts, Charter parties, Shipping services; Port operations, Maritime logistics; Shipping economics; Management; Operations; Maritime Legal Infrastructure; Maritime Safety and Security and Environmental issues.

Communications and Media Management

Students who envision careers in entertainment, television, film, online media, social media or book and magazine publishing can pursue further study in communications and media management. There are also in-depth options available to students who simply want to develop fluency in good executive communication skills. The specialization is extremely customizable: Students can choose courses based on whether they envision a career in a specific media-oriented industry or whether they want to generally sharpen their communication skills for their future roles as professionals and business leaders.

Insurance and Risk Management

The Insurance and Risk Management Specialization covers the areas of life insurance and financial planning, underwriting and selection, mortality trends, general insurance, reinsurance and reserving. The module takes a practical approach and illustrates theoretical principles with examples drawn from actual practice throughout. After completing the module students will be well positioned to enter into a wide variety of interesting careers in this area of financial services which is large, expected to exhibit high long term worldwide growth and is robust to short term economic fluctuations.

International and European Business and Management

This programme is designed for students who want to specialize in the business environment of the European Union. The International and European Business and Management specialization aims to provide students with a comprehensive, in-depth approach to the main fields in Management as they face up to Europe and its realities. This specialization prepares you for an international career in marketing, finance and management, including export management and research. We place emphasis on developing the necessary research skills to understand critically the field of international business and management.

Sports Management

The undergraduate sport management specialization offers professional preparation in the application of business principles to the sport industry. Students will complete a degree program that includes courses in accounting, management, marketing, economics, and computer applications. Sport management courses will focus on the business aspects of sport in culture, sports information, interscholastic intercollegiate and professional sports, facility management, sport ethics, sport marketing, sport law, and sport finance. This programme will give you thorough knowledge and competencies through a solid foundation of theory and practice providing you with ample opportunity for interesting jobs after you complete your education.

BSc IN ACCOUNTING, BANKING AND FINANCE

The Bachelor Programme in Accounting Banking and Finance has a strong focus on practical applications without sacrificing academic rigour. It provides a solid foundation in all of the traditional financial disciplines, giving participants the analytical tools for a successful career in professional and academic posts related to finance, capital market, investment management, corporate finance, and trading or risk management. The curriculum is highly integrated and accelerated, allowing for the study and mastery of a broad range of skills.

The Bachelor in Accounting, Banking and Finance has two specializations, in Banking and Finance, and Accounting.

The first two years of the two paths share the same curriculum that comprises courses in finance, economics, accounting, mathematical and statistical reasoning and business. In the third and fourth year the two paths are differentiated through the use of electives appropriate for each specialisation.

Students who graduate from the course will be well-grounded in financial theory, capital markets, investment management techniques, investment and commercial banking, financial risk management, accounting and insurance.

A career within the field of Accounting, Banking and Finance is exciting and rewarding. The world of finance, with its diverse career opportunities and continuing demand for capable professionals, is an attractive career choice for high calibre individuals. This Programme allows graduates to work within the largest companies of the world including Investment & Commercial Banks, Hedge Funds, economic organizations or the government. Also the rigorous nature of the Programme equips students for graduate work either in accounting or finance or in a business related programme.

The BSc in Accounting, Banking and Finance at Neapolis University Pafos will definitely enhance your career prospects in the current job market.

Career prospects

SPECIALISATIONS IN ACCOUNTING, BANKING AND FINANCE

Accounting

Our Bachelor programmes in Accounting, Banking and Finance offer students a unique opportunity to earn an accredited University degree and at the same time to be trained for a professional qualification, the ACCA. This specialization contains custom-designed courses that satisfy the requirements of the ACCA fundamental stage qualifications. ACCA is the global body for professional accountants that offers a qualification, with international recognition, to those seeking a rewarding career in accountancy, finance and management. The ACCA membership provides improved career progression opportunities and very high earning potential. Graduates in this programme will be exempted from the fundamental papers of the ACCA. The courses studied in years three and four of our degree programme will help with the final stage examinations of ACCA qualification.

Banking and Finance

The aim of the specialization in Banking and Finance, a stream of the degree in Accounting, Banking & Finance, is to provide the necessary education, skills and values to students who seek a career in a finance-related profession in industry, in the financial services sector, in the banking industry, or in government. This specialization is designed to blend the specialised fields of banking, investments, corporate finance, financial accounting, financial management, management accounting, and auditing with the general fields of business management and economics to ensure that students complement their in-depth analytical and professional understanding of financial issues with a wider business and economics education and recognition of the importance of ethical and professional standards.

BSc IN ECONOMICS



In studying economics you will learn how individuals and society make choices about how scarce resources are used, what products are produced and who gets to consume them. These choices depend on evaluating costs, benefits, risks and effects on others. The constraints affecting these choices are many and include income, technology, natural resources,

legislation and time.

Economics is traditionally divided into two broad categories: microeconomics and macroeconomics. Microeconomics involves the decisions of individual units, such as a firm producing goods and trying to make a profit or a household earning income, buying products and trying to achieve the highest level of satisfaction. Macroeconomics looks at the factors that determine the total output of the economy as a whole and analyses the mechanisms that cause inflation, unemployment and growth.

All of our students study microeconomics and macroeconomics, but there is also a great deal of choice within our Programme. Indeed, Economics at Neapolis University is taught in conjunction with the business disciplines of finance, marketing and management and enables students to use economic reasoning taking into account the business context in which economic decisions are taken.

Career prospects

Students graduating from the programme will have a good understanding of key economic concepts, theories, and analytical skills to critically interpret and manipulate economic data. They will possess communication, IT and research skills to express their views in a professional and effective way and will have acquired through their training the ability to work effectively as part of a team. Graduates of the Programmes will be ready for successful careers in the financial sector, in government as economists, or for graduate study.

Programme duration: 4 Years

BACHELOR IN LAW (LLB)



The Programme is aimed at familiarizing the students with the most important concepts and principles governing the Greek and Cypriot legal system, as these interact with, and are influenced by, the international and the European Law. Particular emphasis is placed on the commercial law and European Union law, whereas academic knowledge is combined with the appropriate practical experience. The Programme completely covers the necessary

knowledge a student must have, in order to become accepted from the Bar association of Greece and take part in the exams of the Cyprus Bar association.

At the end of the Programme the student will be able to:

- Recognize the basic concepts and principles governing the legal systems of Greece and Cyprus, as well as the influence of the international legal system and the European Union Law on them
- Understand the political and social parameters which affect the law-making process and its application
- Conduct a legal research in a methodical and effective manner, in order to construct arguments
- Be able to conduct critical analysis and legal reasoning and use these skills in order to deal with particular legal issues
- Structure comprehensive and consistent law arguments and express himself/herself verbally and in writing with clarity and precision
- Evaluate the various legal arguments and select the most appropriate ones, according to the case at hand
- Pinpoint the most important legal issues arising from complicated cases and deal with them successfully
- Use his/her academic knowledge in order to deal with actual law cases

Career prospects

The graduates of the Neapolis Law School may be registered with the Bar association of Cyprus and the Bar associations of other European countries, as they will fulfil the necessary requirements for Legal practice.

Programme duration: 4 Years



BACHELOR & DIPLOMA IN ARCHITECTURE

The School of Architecture, Land and Environmental Sciences considers architecture to be a manifestation of the social and cultural life of a place, a natural expression of human activity and a regenerating force in the natural and the built environment.

In today's world, architecture, like most fields of knowledge, faces two main challenges:

- The demand for a respectful and protective treatment of the natural environment (through saving and using "clean" energy, advanced technology and the appropriate design decisions) and
- The preservation of local identities in an increasingly globalised society (through the activation and enhancement of the cultural qualities and the natural features of each place)

Bearing in mind all of the above, the philosophy of the Programme is based on the triptych of **culture**, **nature** and **technology**, their interaction and relationships. Therefore, as a response to these challenges, the Programme is established on two principles: an **ecological approach** to architectural design and the **comprehension and reinterpretation** of local architectural features.

The Bachelor degree comprises 240 ECTS. The Bachelor of Architecture Programme is unified with the Diploma of Architecture Programme as a five-year Programme in Architecture (300 ECTS in total). Bachelor and Diploma Programmes are consistent with the required criteria for European and international recognition of the degrees.

An innovative feature of the Programme is the option to select a specialization path that deepens the student's understanding in one of the following areas:

- Architectural Design
- Landscape Urbanism
- Bioclimatic Architecture and Sustainable Development
- Conservation-Rehabilitation of Historic Buildings and Sites.

The Diploma in Architecture is an academic qualification accepted by the Cyprus Technical Chamber (ETEK) for registration as a professional architect in Cyprus.

Career prospects

The Diploma in Architecture fulfils the requirements set by the EU Directives 85/384/EC and 2005/36/EC for the recognition of Professional Qualifications, and the recommendations of UIA (Union International of Architects). The Diploma is recognised by the Cyprus Scientific and Technical Chamber (ETEK) (following requisite one year's work experience) and the Technical Chamber of Greece (TEE) with the same recognition procedure followed for the graduates of Greek Architectural Schools. Graduates can work both at home and abroad.

Programme duration: 5 Years

BACHELOR IN LANDSCAPE ARCHITECTURE



The Bachelor in Landscape Architecture is unique in Cyprus, offering in-depth study on the design and management of natural and man-made landscapes.

The Programme aspires to provide its graduates with in-depth knowledge on designing and planning landscapes of various scales; from public squares to private gardens; from golf courses to seafront developments;

from highways to national parks; from reclaimed brownfield sites to historic monuments; from urban regions to protected natural areas. Although broad in scope, the Programme's particular focus is on the Mediterranean landscape, concentrating on its variety of cultures, climate and plants. As part of their studies, students will be introduced to leading landscape studios and practices, face environmental, technological and cultural issues, discuss contemporary design theories and confront a wide range of landscape design problems.

BSc IN CIVIL ENGINEERING

BSc IN LAND SURVEYING ENGINEERING



Land Surveying is the engineering science and practice of recording and setting out the exact measurements of man-made and natural features of the earth's surface. To survey means to view, examine and inspect in detail. Surveying Engineering is basic to all construction planning and development. Amongst others, it involves the making of maps and the determination of boundaries.

During the first two years the students obtain a strong scientific background on mathematics, physics, computing, economics and basic engineering issues enabling them comprehend advanced engineering topics. In the last two years the programme places a high priority on the integration of theory and practice and provides in depth coverage of all aspects pertaining to Geodesy, Cartography, GIS, Remote Sensing, Soils, Construction, Cadastre, Land Management, Hydraulics, Hydrology, Transportation, Water Resources and Environment.

We have created a rigorous, collaborative learning environment that encourages learning initiatives, exploration and discussion in all aspects that pertain to Land Surveying Engineering. BSc IN QUANTITY SURVEYING & CONSTRUCTION ECONOMICS



Quantity Surveyors (QS) are the professionals who have a general set of skills that can be applied to a diverse variety of problems which are predominantly related to costs and contracts on construction projects. A QS is responsible for the measurement and pricing of construction work, but specifically that actually performed by the contractor (and the contractor's subcontractors) as opposed to the construction work described and measured in the construction contract between the owner and the contractor. Such a

difference in quantity of work may arise from changes required by an owner, or by an architect or engineer on an owner's behalf.

During the first two years of their studies, the students obtain a strong scientific background on Mathematics, Business Management, Computing, Accounting, Economics, Organizational Behavior and basic Engineering issues.

In the last two years the Programme places a high priority on the integration of theory and practice and provides in depth coverage of all aspects pertaining amongst others to Real Estate Economics, GIS, Finance, Construction Management, Real Estate Development, Advanced Engineering issues, Construction Law and a Dissertation thesis.

We have created a rigorous, collaborative learning environment that encourages learning initiatives, exploration and discussion in all aspects that pertain to Quantity Surveying. Theory and practice are perfectly balanced in our course which aims to prepare high calibre individuals with the broad understanding, technical knowledge and personal skills necessary to operate efficiently in the surveying and engineering industry. The role of Quantity Surveyors nowadays extends further than the day to day running of building projects and covers such other areas as sub-contract formation, forecasting of costs and values of the project, cash flow forecasts and the collation of the operation and maintenance manuals of the project. This day by day increase in the capacity of the quantity surveying profession has led to an increased demand for qualified personnel and goes some way to explaining the popularity of related degrees at University.

Career prospects

Quantity Surveying offers a choice/ mix of office or site-based roles. Graduates find employment at a technical level with Professional Consultancy Practices, Building and Civil Engineering Contractors, a variety of Sub-Contracting specialists, Property Developers, Insurance Companies, Local Authorities, Government Departments, State/Semi-State Organisations and Builders Suppliers.

BSc IN REAL ESTATE VALUATION AND DEVELOPMENT

The Bachelor in Real Estate Valuation and Development is the first and only undergraduate Programme in the field of Real Estate in both Cyprus and Greece. This four-year Programme prepares the students for a successful career not only in the field of property valuation but also in many other professions that are related to Real Estate, such as land development, real estate investments, consulting services pertaining to real estate development and investment, real estate financing, real estate agency, etc. Graduates of the Programme will be able to also pursue job vacancies in related government agencies such as the Department of Lands and Surveys.

The Programme has been approved by the Cyprus Technical Chamber and graduates of the Programme will be able to register as licenced property valuers. Graduates of the Programme will be also eligible to take the exam for registering with the Cyprus Real Estate Agent Registration Council as licenced real estate agents.

In the first year, the course includes several introductory courses in all disciplines that are related to real estate, such as economics, finance, business, accounting, construction, mathematics and computers. In the second year, students are offered additional introductory courses in marketing, management, finance, construction and statistics, as well as some other courses more closely related to real estate, such as land planning, real estate law and urban economics.

In the third year, the course focuses exclusively on real estate with several valuation-related courses, as well as courses in real estate finance and real estate economics. Finally, in the fourth year, the course focuses on real estate project development and investment. Furthermore, during this year, students are required to complete a dissertation, which aims at developing their research skills.

Career prospects

Graduates can work in a property valuation firm or they can establish their own firm. Furthermore, they can be employed at commercial or cooperative banks or in the public sector (for example the Department of Land and Surveys). Last but not least, after one year practice, they can sit the exams and get the license in order to practice as registered estate agents as well.

Programme duration: 4 Years

BSc IN PSYCHOLOGY

The Bachelor of Science in Psychology Programme seeks to provide students with an understanding of the cognitive and affective processes that underlie human experience and behaviour. It provides students with the techniques by which behaviours are evaluated and modified and with techniques of the application of theoretical principles to solve behavioural problems. It also focuses on the connections of behaviour and mental processes with biology and social sciences.

This objective is achieved through a very rich and well-designed programme of study, which extends in four full-time years and comprises 240 ECTS. The majority of ECTS are gained from the content-specific courses that cover the major areas of Psychology, such as Cognitive, Developmental, Clinical, Counselling, Social and Educational Psychology. General education courses, electives, a Thesis and a practicum intend to broaden the scientific knowledge and skills which are essential for every psychology graduate.

Our psychology students are benefited from lectures that foster interaction with students, in-class activities, tutorials and use of audio-visual material in well-equipped lecture rooms. Furthermore, students enjoy the unique opportunity to gain first-hand experience in the research labs of faculty members and are encouraged to work with the faculty on various research projects.

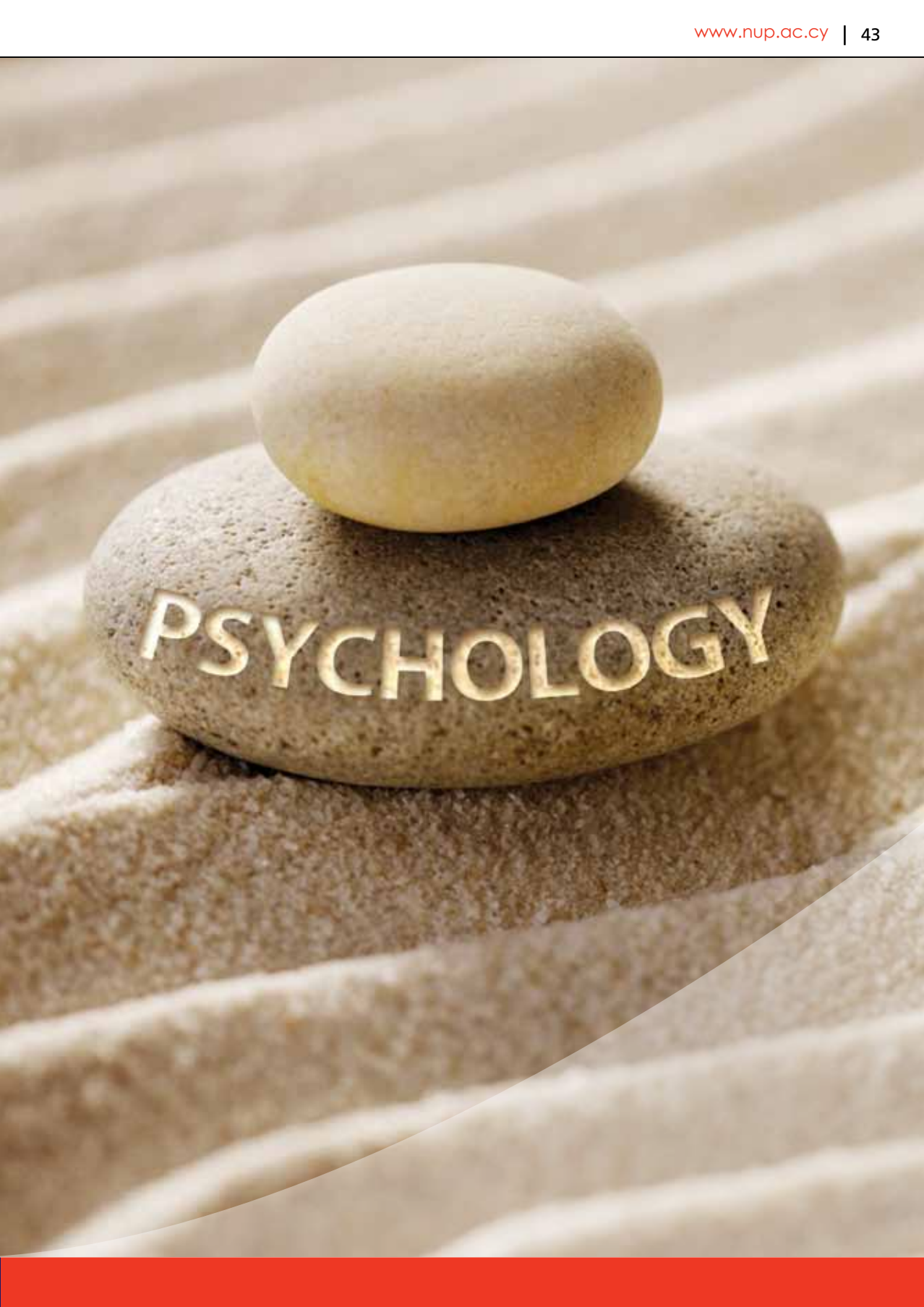

MASTER IN BUSINESS ADMINISTRATION (MBA)

The MBA Programme at Neapolis University Pafos provides an advanced course of education to those aspiring to follow a successful career in management. The key mission of the Programme is to enable students to realize their potential through a pedagogical approach that employs theories and rigorous reasoning to inform practice that utilises the participants' work experience, that instils new skills, and that provides new knowledge in a real-life business environment.

The MBA Programme develops the participants' ability to make informed professional decisions, by broadening and deepening their understanding of market, financial and management functions and processes; it equips students with skills of business research, analysis and modelling, and emphasises the role of creativity in a continually changing and competitive business environment. All students are encouraged to understand the role of information and technology in innovation and to become aware of ethical, social, environmental and global issues affecting management decisions.

The Programme is tailored to the individual needs of working students and provides a flexible route to an advanced Master degree. The Programme is delivered with a combination of weekend teaching (approximately one each month) and e-learning technology which allow students to participate in the programme from anywhere they live. The Programme runs over two academic years and is delivered by combining face to face tutoring, with a variety of distance-learning sessions, and state-of-the-art web-based support.

The Programme offers the following specialisations: Marketing, Sports Management, Communications and Media Management, Insurance and Risk Management, Entrepreneurship and Innovation Management, Accounting, Management of Information Systems, Shipping Management, Tourism Management, Financial Management, Real Estate and Construction Management.

Career prospects

Graduates will find employment in a range of careers such as business analyst, business consultant, and business manager, government and/or private sector administrator, production supervisor, project planner, and sales and marketing manager. The specializations offer the skills to pursue careers such as public relations and fundraising manager, human relations manager, advertising or media professional, purchaser, buyer or trader, sales executive and supply chain manager. Moreover, graduates can pursue careers within corporate training, human capital consultancy, international human resources management and occupational health.

Programme duration: One or two years

SPECIALIZATIONS IN BUSINESS ADMINISTRATION (MBA)

Marketing

The specialization in Marketing builds on the principles of marketing and deals with the managerial aspects of marketing. The module emphasises the quantitative and qualitative criteria used in evaluating marketing alternatives and in choosing among these alternatives. The course includes topics related to market segmentation, marketing research, product/service development, branding, promotion, and pricing, channels of distribution, marketing strategy, and global marketing. On completion of the specialization students will have developed the skills needed to analyze and solve complex marketing problems through case analysis.

Communications and Media Management

This programme looks at digital media companies' operations, production strategies, advertising and business plans – at how they are growing, organized, and obtain financing. As the markets and technologies for entertainment and advertising are transformed, the focus will be on the business plans of new firms, and the efforts of yesterday's leaders to keep up. Each week, executives will visit from companies innovating in such areas as: branded entertainment, financing digital entrepreneurs, mobile media and sports management, social media, and videogames.

Sports Management

The primary objective of the MBA - Sport Management is to train and develop the Sport executive and administrator of the 21st century. The MBA specialization in Sport Management is committed to producing top-notch managers and executives who are practitioner-oriented and are educationally, professionally, and ethically sound. MBA - Sport Management combines a superior, rigorous graduate business curriculum with a specialization module that emphasizes the business of sport. The programme is practitioner oriented and students will be expected to participate in out-of-classroom practical experiences at local and regional sport and/or entertainment entities.

Insurance and Risk Management

The MBA specialization in Insurance and Risk Management combines a strong core curriculum in fundamental business disciplines with expertise in managing organizational risk. Focus is given to the insurance industry, yet with an eye towards enterprise-wide risk management. Students who graduate from our Insurance and Risk Management Programme, do so with exceptionally strong critical thinking and analytical skills, aided by a vast array of experiences interacting with business professionals in risk management consulting, finance, and operations. This specialization has been developed with the direct support of company leaders in Insurance, Finance and Consulting.

Entrepreneurship and Innovation Management

The specialization in Entrepreneurship and Innovation Management covers a variety of topics in applied entrepreneurship. The course will rely heavily on outside speakers and lecturers who have personal experience as entrepreneurs. The course is based on virtually all other courses of the business degree curriculum and gives an opportunity to students to apply their knowledge and develop their skills. Each student will exit the course knowing and experiencing what it really takes to start and operate a profitable business leveraging limited resources.

Management of Information Systems

This specialization covers many of the features and concepts that introduce the student to third generation language computer programming. The first two thirds of the course focus on introducing the student to the fundamental concepts of procedural structured programming. The concepts of Input Process Output Storage and Control are embedded and the structured programming techniques of Sequence, Selection Iteration to process interactive data or sequential files are used. At the last third of the course, elementary concepts of objects are introduced along with their basic properties.

Accounting

The MBA specialization in Accounting introduces students to the basic accounting concepts and principles and the role of the financial statements and the annual report in the financial reporting process. The specialization analyzes the income statement, balance sheet, statement of cash flows, footnotes and the annual report in the financial reporting process. Students will learn the techniques of computing ratios in preparation for financial statement analysis, interpret the ratios and study the limitations of ratio analysis.

Tourism Management

MBA in Tourism Management has been developed to address the need for a programme that combines the study of modern management theory and practice with application into the area of tourism. The fundamental philosophy of the programme is to help students pursue academic studies at the highest level while maintaining business relevance. The MBA in Tourism Management builds on Pafos's long-standing tradition as one of the most successful tourist destinations in the world as well as on the expertise of the staff in tourism research and development.

Shipping Management

The mission of this unique MBA specialization in Shipping Management is to give high potential executives in shipping industry an up-to-date insight into modern management theories and their application in the maritime sector. The general objective of MBA in Shipping Management is to ensure that after successfully completing this program, the students can obtain management positions in the shipping, cargo and port industry. Further the students are equipped to solve complicated management problems, having gained the required knowledge and competency.

Real Estate

The MBA programme with a specialization in Real Estate is designed to equip students with a broad background in real estate investment, appraisal and development. It focuses on the delivery of advanced real estate analysis skill sets that are recognized as crucial within the commercial investment real estate marketplace. The core modules cover a wide variety of topics including; real estate finance, valuation, development, market analysis and economics. Graduates are prepared as real estate investors and entrepreneurs, who can buy, sell, renovate, and rent residential and commercial properties for their own portfolios or companies.

Financial Management

The aim of this specialization is to present students with a conceptual framework to analyze the investment, financing, risk management and income distribution decisions of corporate decision-makers. Students will study methods of evaluating potential investments using alternative criteria, the impact of taxation and alternative financing schemes on the value of a potential project, the evaluation of potential acquisition or merger targets, and the impact of dividend policies on the value of the company. Additional topics include the hedging of financial and business risks and the management of short term assets and liabilities.

Construction Management

The MBA programme with a specialization in Construction Management is designed to prepare students for careers in the growing field of the management of construction projects. It includes a balanced focus on the technical construction knowledge – like methods and materials, construction processes, and surveying – and on the managerial, financial, and planning skills necessary for taking charge of construction activities. Graduates will develop the skills and knowledge needed to successfully complete construction projects on time and within budget, adhering to construction standards and safety guidelines.



MSc IN BANKING, INVESTMENT AND FINANCE

The MSc in Banking, Investment and Finance is specifically designed to meet the demands of the banking and finance industry. The challenges of the current global economic environment will be a platform for your studies. You will consider issues from around the world, analyze and evaluate problems and identify the best solutions to further improve and develop banking, investment and finance strategies and practices.

The Masters Programme offers training in the key areas of investment, banking and financial investment. You will acquire an understanding of how financial markets operate, particularly in relation to the aims and operations of banking organizations and institutions. You will also study corporate finance theories and techniques including credit risk management, capital structure and dividend payout policy.

The Master Programme will provide you with a rigorous treatment of the theory of international finance and investment, and training in the techniques and practice relevant to the international financial setting. The objective is to create independent specialists combining quantitative and operational skills together with institutional competencies. For this reason the technical skills developed in our program are complemented with courses dedicated to more general economic and institutional aspects of finance. The learning process has a practical orientation and takes the form of structured lectures backed up by practical applications through case studies and visiting speakers as well as project works and individual research.

The Programme offers the ideal preparation for advancing or beginning your career in the world of banking, asset management, financial consulting, or other finance-related fields. At the same time, the rigorous and research-oriented approach ensures a thorough preparation for further academic studies, particularly for a Ph.D. degree.

Career prospects

Master in Banking, Investment and finance graduates enjoy a wealth of career choices within and beyond the banking sector. You will be equipped for success in fields such as credit and marketing, corporate finance and consultancy, financial planning and services, investment and wealth management, trade finance, treasury, risk management as well as settlements and operations management. 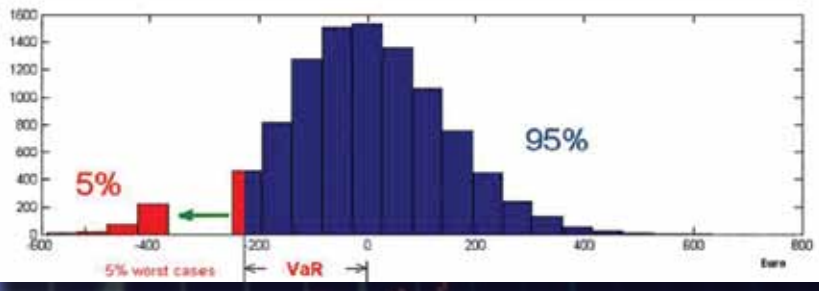
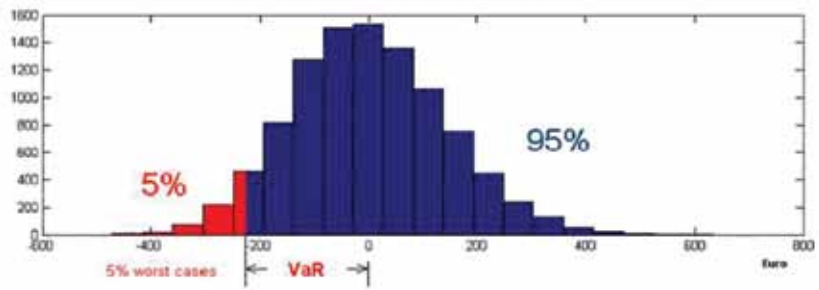

MASTER IN PUBLIC ADMINISTRATION (MPA)

The aim of the MPA Programme is to provide a course of advanced study to those who aspire to become effective leaders in the public sector. The Programme's curriculum is designed to explore the essential elements of public management and policy and to prepare students for increasingly complex responsibilities in the public sector, local government, and non-profit organizations. The core curriculum emphasizes both the skills and knowledge required to effectively manage and develop organizational resources and to understand the larger constitutional and political setting in which policy is developed and administrative tasks are defined and assessed.

The Programme provides up to date knowledge in a number of diverse areas that make up the field of public administration, such as finance, economics, organisational theory, management, politics and law. In addition, the Programme equips students with technical, analytical, ethical, accountability, and leadership skills to enhance their decision-making ability and to promote organisational well-being within the context of a continually changing and competitive economic environment. At the beginning of the second year students have the choice to select one of the three specialisations concerning (a) General Administration, (b) Management of Health Services and (c) Management of Educational Services.

A fundamental philosophy of the Programme is its empirical approach to the study of public administration, where the acquired new knowledge and skills are blended with the participants' experience and are applied from the beginning to real-life cases.

This approach broadens and deepens student understanding of management issues and policy processes; it fosters skills of research, analysis, synthesis and creativity; and it encourages innovation and awareness of the role of information and technology in innovation; finally it develops awareness of ethical, social, environmental and global issues affecting management decisions. In order to meet the requirements of the Programme, students take 8 courses and complete a Dissertation.

General Administration

Those students who wish to follow this specialization have to attend the following courses, which are taught in the third and fourth semester:

- **Public Sector Administration**
- **Strategic Planning and Effectiveness of the Public Sector**
- **Planning of Public Policies: Evaluation and Implementation**

In general, the curriculum covers a variety of issues concerning public policies, financial issues, human resources management, health, education, environment, security and E.U. issues. This specialization is addressed to those who intend to follow a career in Public Services, Public Organizations and Independent Authorities, as well as Local Government Agents, and aims at the development of staff with skills and competences of high caliber.

Public Educational Administration

Those students who wish to follow this specialization have to attend the following courses, which are taught in the third and fourth semester:

- **Administration and Management of School Units**
- **Communication and Cooperation at School**
- **Planning and Development of Analytical Curricula**

The specialization in question is addressed to educators at both the private and the public sector. In general, the issues covered concern a methodological approach and analysis of the functioning of the Educational Sector and the role it plays within the Public Policy, as well as the management of the Sector at a micro-level, the School. The Programme scopes to educate those who are interested in assuming leading positions in the specific sector.

Management of Public Health Care

Those students who wish to follow this specialization have to attend the following courses, which are taught in the third and fourth semester:

This specialization is addressed to Medical Doctors, Staff Nurses, Administrative Personnel in Health Units and Corporate Executives in Health companies in both the Private and Public Sector. In general, the issues covered concern a methodological approach and analysis of the functioning of Health Units and the role they play within the National Health System. The Programme scopes to train those who are interested in following leading careers in the specific sector.



MASTER IN EUROPEAN GOVERNANCE (MEG)



The Master's Programme in European Governance is an incisive one-year Programme designed to create experts in European affairs. It provides students with a comprehensive understanding of the prevailing processes and practices that govern European Union decision-making and the workings of the European institutions. Successful applicants are working professionals who want to enhance their

careers or graduate students looking for exciting global career options in both the private and public sectors.

In the first semester, students take four compulsory courses covering Introduction to European Integration, Introduction to Public Administration, European Political Economy and European Union Law. The second semester builds on the foundation of the previous term by allowing students to go into further depth on the EU's economic, legal and political implications. It comprises four compulsory courses: Europe and the World, the EMU and Economic Governance, European and Mediterranean Politics, and European Negotiations and Lobbying. Students are required to write a Master's thesis in one of the courses.

Students benefit from the teaching expertise of leading academics and the on-ground experience of practitioners. Teaching is designed to engage and challenge students through "real-world like" case-studies, study teams that will work in the collaborative manner that prevails in European practice and student-centered learning that will urge students to relate what is covered in the course to their professional experience. The intention in MEG education is that each student actively contributes to the learning process through expertise sharing and leading of discussion.

Career prospects

Unlike many other similar programmes, this Master focuses more on the knowledge and practical skills that the modern civil servant, lawyer, businessman, economist etc. need to obtain in order to successfully compete in the growing international and European environment. Graduates will also be able to effectively seek executive positions in international organizations, large corporations, consultancies, legal and accounting firms, non-governmental organizations, etc.

Programme duration: One or two years

MASTER IN INTERNATIONAL AND EUROPEAN BUSINESS LAW (LLM)



This Master aims to provide a high-quality Programme for those aspiring to become successful law practitioners, consultants and academics specialized in International and EU Business Law. The curriculum is designed to explore the basics of International and EU Business Law and to prepare students for the increasingly complex legal transactions and negotiations, in areas such as banking, transport and energy. The core courses focus on the skills

and knowledge needed to understand multi-jurisdictional legislation in the wider system of International and European Business Law.

The Programme provides up-to-date knowledge in many areas of law which constitute the field of International and European Business Law, such as commercial law, the law and regulation of competition, energy law, banking and insurance law, tax law and corporate governance. Lawyers and Law School graduates will additionally be provided with essential knowledge in Political Science and Economics and will be equipped with analytical, accountability and leadership skills in order to enhance their decision-making capacity and to promote good practice within the context of a changing and competitive International and Business Law environment.

The fundamental philosophy surrounding the Programme is to offer an empirical approach to the study of Business and Law, where the newly acquired knowledge and skills are combined with students' experience to be promptly applied in the actual working environment.

This approach both broadens and deepens the students' understanding in multi-jurisdictional legislation and cross-border legal issues. Additionally, it reinforces their skills of investigation, analysis, synthesis and creativity and helps them comprehend the role and importance of legal advice in international legal acts.

Career prospects

The Programme explores the fundamentals of International and European Business Law and prepares students to successfully handle complex legal transactions and have an active role in legal negotiations, most notably in the banking, transport and energy sectors.

Programme duration: One or two years

MASTER IN LANDSCAPE ARCHITECTURE (MLA)

The Master in Landscape Architecture is unique in Cyprus, studying the design of natural and man-made landscapes, and aspiring to cover the educational gap in this academic field.

The main objective of the Programme is to promote knowledge in Landscape Architecture, and to provide training and research opportunities that may complement the work of architects, planting engineers etc. and may upgrade contemporary living conditions for all. The Programme focuses on the Mediterranean conditions in urban, rural and coastal contexts, with a strong emphasis on sustainability and ecology. Another aim is to develop the students' skills on designing and managing landscape as well as conducting research, on any scale, from the private garden and the urban square to the national level, and in any theme, from the natural to the man-made environment (e.g. protected areas, industrial and brownfield sites). Students will also confront environmental, technological and cultural concerns, and acquire knowledge of contemporary theories and methodologies in landscape design.

The Programme aspires to provide graduates with an increased awareness of environmental and social issues, to stimulate sustainable growth through landscape design and to train students for a successful career in landscape architecture or a relevant research sector.

Candidates should normally have completed a five year undergraduate degree in architecture, or a four year degree in forestry, agriculture, landscape architecture, environmental science or in related disciplines in recognized institutions in Cyprus or abroad.

Career prospects

The Master in Landscape Architecture programme will offer full professional qualifications in Landscape Architecture in European and International level. It complies with the specifications of European Foundation of Landscape Architects (EFLA), the International Federation of Landscape Architects, the Landscape Institute (UK), the Greek Association of Landscape Architects where graduates will be eligible to apply for professional registration (following requisite work experience) and work both at home and abroad.

Programme duration: One or two years





MSc IN CONSTRUCTION MANAGEMENT

The postgraduate Programme in Construction Management prepares the students for management positions in one of the largest industries in Cyprus. Its mission is to provide a course of advanced study designed to serve the managerial needs of the construction industry. The Programme has been designed to fit the busy schedule of working professionals and as such it is taught during weekend sessions that take place twice a month.

The Programme is designed to accommodate both graduates of "technical" degrees, as well as those from business or economics backgrounds by offering appropriate remedial technical modules. The course is intended for entry-level managers, project engineers, and related supervisory personnel who are interested in broadening their construction management knowledge base, sharpening their management acumen, and preparing themselves for advancement opportunities and leadership positions within the construction industry.

The Programme provides knowledge and skills that cover all aspects of the construction industry, including state-of-the-art processes, production techniques, design functions, research applications, management methods and leadership skills. Specifically, the Programme seeks to provide students with a thorough understanding of:

- Basic management principles as applied to the construction industry
- Principles of leadership in the construction industry
- Integration of modern technology in construction
- Innovative management tools for the analysis and control of construction projects
- Principles and methods of planning and financing construction projects
- All aspects of addressing safety and health issues in construction sites
- The various sustainability and environmental issues that need to be taken into account in real estate development and construction.

Career prospects

Graduates of the Programme will be well-equipped to pursue leading positions in construction companies and real estate development companies, as well as in relevant departments in the public sector.

Programme duration: One or two years

MSc IN REAL ESTATE



The Master of Science in Real Estate is the first postgraduate Programme in Real Estate in both Cyprus and Greece. The Programme has been designed to fit the busy schedule of working professionals and as such it is taught during weekend sessions that take place twice a month.

This Programme covers all the aspects of the real estate sector and equips students with knowledge and skills that will allow them

to pursue management positions in a wide spectrum of companies that are involved in real-estate-related activities, such as land development, real estate investment, real estate financing, consulting services pertaining to real estate development and investment, property and portfolio management, real estate agency, etc. Graduates of the Programme will also be qualified to pursue management positions in relevant government agencies, such as the Cyprus Department of Lands and Surveys. Furthermore, they will be eligible to take the exam for registering with the Cyprus Real Estate Agent Registration Council.

In a learning environment that is supported by the most advanced educational technologies, the students of the postgraduate Programme in Real Estate will acquire an excellent and comprehensive knowledge of all theoretical and analytical aspects pertaining to the analysis of real estate markets for real estate development and investment purposes, the financing of land development projects and real estate investments, as well as the valuation and management of real estate assets. Overall graduates of the Programme will develop:

- A comprehensive understanding of the process, the approaches, the methodologies and analytical techniques that are needed for securing a professional role in the real estate industry
- The necessary theoretical and analytical frameworks as well as critical thinking capabilities that will allow them to successfully pursue management positions in both the private and the public sector

Career prospects

Graduates of the Neapolis MSc in Real Estate are already employed in a variety of property related jobs. They are valuers in the public sector (Department of Land and Surveys) or in the private sector. Some others have a job in the property development sector, while others are practicing as estate agents or as high ranking executives in investment firms. Of high importance is that they can be approved from the Technical Chamber, after attending some extra modules from the BSc programme.

Programme duration: One or two years

MSc IN EDUCATIONAL PSYCHOLOGY



Educational Psychology is a distinct scientific discipline within psychology that is concerned primarily with understanding the processes of teaching and learning that take place within formal environments and developing ways of improving the affiliated operations and procedures.

The MSc in Educational Psychology focuses on the study of cognitive, emotional, and social learning processes that underlie education and human development across the life span. The Programme is targeted towards school educators who want to gain expertise in the normal and atypical patterns of development and learning. More specifically, the Programme aims at providing students with evidence-based knowledge and skills concerning the learning theory approaches and their educational implications, the wide spectrum of learning difficulties across the life-span, the domain – specific psychological development from infancy to adulthood and its impact on the learning processes. The main developmental disorders as they are manifested in childhood and adolescence, the awareness of the role that cultural and social factors play in the educator's interaction with students and parents constitute salient dimensions of the MSc Programme in Educational Psychology.

The Programme is made up of two distinct but complementary components: Core Courses and Elective Courses. The Core Courses are focused on aspects of psychological development and learning as well as on their atypical dimensions. In particular, both earlier and more recent approaches to the development of cognitive, emotional and social domains are analyzed and evaluated with the emphasis given on the school and adolescent years. The respective approaches to learning are discussed and analyzed with respect to their educational applications. In addition, the Core Courses include topics such as the Development of Personality, Language and Literacy, Multicultural Dimensions of Behaviour, Methodology and Statistics.

The Elective Courses cover a wide range of topics such as Developmental Psychopathology, the Formation of Adolescent Identity, Adolescent Delinquency, Adult Education and Counselling in the School Community.

Career prospects

The Programme is suitable for both experienced and aspiring educators who wish to enhance their career. The Programme is also appropriate for psychology graduates who wish to pursue a research or academic oriented career in Educational Psychology.

Programme duration: One or two years



MSc IN COUNSELLING PSYCHOLOGY

The main objective of the Masters Programme in Counselling Psychology is to provide specialized knowledge while simultaneously educating the students with the intervention techniques used in the counselling process. The main goals of Counselling Psychology focus on promoting a healthier way of living through supporting individuals faced with difficulties in handling problematic situations and crises in their personal, educational, familial or occupational lives. Utilizing a wide range of modern theoretical and research-based approaches, mainly from the field of Psychology and Psychometry, the MSc Programme in Counselling Psychology aims at satisfying the needs of the society by developing professionally trained individuals who will provide their services to a wide range of welfare and support services in education, organizations and other institutions.

The structure of the Programme is based on three axes. On the *first axis* are the courses referring to research methodology, statistics, diagnostic methods and independent study. On the *second axis* are the courses referring to abnormal behaviour and diagnoses relating to all developmental levels of human life. The *third axis* embraces the courses relating directly to the counselling process such as Ethics, Career Counselling, School Counselling, Health Psychology, as well as counselling with couples, families and groups. The Programme gives an emphasis on the critical assessment and implementation of different theoretical orientations, as they relate to the counselling process. Students are expected to complete a total of 1500 hours in a variety of practicum sites during the second and third year of their studies where they will have the opportunity to bring theory into practice in a hands-on and professionally supervised manner. The Programme is taught in the Greek language.

Career prospects

Graduates are employed in a variety of settings depending on the services they provide and the client populations they serve. Some are employed in colleges and universities as teachers' supervisors, researchers, and service providers. Others are employed in independent practice providing counselling, psychotherapy, assessment, and consultation services to individuals, families, groups, and organizations. Additional settings in which counselling psychologists practice include community mental health centers, hospitals, family services, health maintenance organizations rehabilitation agencies, business and industrial organizations and consulting firms.

Programme duration: 3 Years

MASTER IN GREEK CIVILIZATION



The Master Programme in Greek Civilisation reflects the priorities of the NUP mission and is designed to provide a course of studies that meets local and national needs. The Programme covers four important aspects of Greek civilization, namely Philosophy, History, Literature, and Art. The aim of the Programme is to provide students with the opportunity to study at Master's level different aspects of Greek culture and

civilisation, such as Philosophy, Politics, Language, Literature, History, Drama, Art, Science and Religion.

During the Programme major themes of Greek Civilisation are discussed, not only in a chronological order, i.e. from antiquity up to modern times, but also on an interdisciplinary level, to show how the major four aspects of Greek civilization interact with each other. Thus, for example, historical themes are studied from the Persian wars, through Byzantium to Modern Greek state and the establishment of the Republic of Cyprus. Similarly, Greek literature covers the entire 3000 years of literary tradition from Homer to the postwar generation. The classical heritage of Europe in Drama, Philosophy and Art is covered extensively in the Programme. Particular emphasis is given to issues of culture, art, religion and history pertaining to Cyprus in order to promote a better understanding of the factors that have affected and shaped the cultural and political landscape of Cyprus over the centuries.

In order to meet the requirements of the Programme students must attend 8 core courses plus 2 electives while they must also submit an MA Dissertation. Each course represents 7.5 ECTS, whereas the MA Dissertation is valid 15 ECTS. The Programme as a whole is worth 90 ECTS. A great advantage of the Programme is that students can choose the topics they study, thus creating their own portfolio.

Career prospects

It is well known that the professional life of every scholar is promoted when based on the knowledge and application of humanistic values. The Master in Greek Civilisation studies the Greek and Cypriot civilisation from antiquity to modern times with special emphasis on its History and Literature. Together with the promotion of humanistic values which are intrinsic to the Greek Civilisation, the Programme most importantly attempts to underline the close interrelation between Greek and Western thought.

Programme duration: One or two years

MASTER IN THEOLOGICAL STUDIES



It is the first time that Theological Studies are offered in Cyprus on a postgraduate level, after receiving approval by the Ministry of Education and Culture. This Programme aims at responding fully to the needs both of the Church and of the Education.

Clergymen and Theologians, as well as teachers, who teach the subject of Religion, philologists or graduates of the School of Humanities are now provided with

an alternative for lifelong training. The Programme offers the possibility of engagement with the highest achievements of human thought, assisted by the divine wisdom.

The main aims of the Programme are:

- To instruct the students in such a way, so that they will be able to respond to the multiple demands of Education and to the remarkable deeds performed for the society by the Church during the past 2000 years.
- To create an international center for Theological studies and an independent tribune for the interreligious dialogue and culture, at Neapolis University of Pafos
- To provide postgraduate studies of high quality to Theologians, spiritual people and scholars in Humanities who wish to deepen their knowledge of theological issues and acquire skills which will contribute to their professional and personal growth.

The quality of the Programme and the variety of the areas covered will offer the holders of the Master Diploma in Theology the possibility to reinforce their services as specialized clergymen or laics at Secondary Education; as teachers; as directors at schools; as active members engaged in the preaching or missionary work of the Church; in the area of ecclesiastic journalism; at the social work performed by the Church or by other public and private institutions; at the Secretary Office of the Dioceses; at Charity foundations; at the excavations of Christian archaeological sites; at the sector of religious tourism; at research.

Career prospects

The Department of Theological Studies offers an innovative Programme which has a wide target group, mainly connected with Education. The holders of this Postgraduate Degree:

- can be employed in administration, e.g. as secretaries at Dioceses
- can perform ecclesiastical and social activities
- can work as assistants at archaeological sites/excavations
- can work as journalists or researchers at several Centers of research, etc.

Programme duration: One or two years

Career Service

The aim of the Career Service is to provide both students and graduates with information about vacancies in their field, either in the public or private sector. Students can call in the Office in person or find information on the NUP website or notice boards. Student Services also organize 'Career Days' in their effort to connect the academic life with the job market.

Academic Advice

After registering with NUP, all students are appointed a personal Academic Tutor. Via this service NUP offers continuous academic support to all students towards completing successfully their studies. The personal Academic Tutor monitors the student's progress on a regular basis, while providing him/her with all the help needed. With the student's consent, the Tutor also informs the other academic tutors about the student's personal concerns or problems.

Financial Support

Students who have difficulties in funding their studies may visit the Student Services Office for further guidance. Each year a great number of students receive financial aid or scholarships from NUP.

Student Consultation

The NUP Centre for Psychological Support and Assessment offers consultation services and psychotherapy on an individual, group or family level, if needed – the service is strictly confidential.

Student Accommodation

The Student Services Office is responsible for all issues regarding the accommodation of undergraduate and postgraduate students in NUP's Hall of Residence, such as processing student applications for accommodation, students' rooms, and maintenance issues.

Medical Support

The Student Services Office offers information about all available options for medical support and insurance in Pafos. Apart from Pafos General Hospital, there are several private clinics in Pafos. Iasis Hospital, for example, is only 1 km away from NUP – it has an Emergency Department and is equipped with specialised doctors in all main medical Departments.

Admissions

The University admits students irrespective of nationality, race, religion, or gender, provided that they meet the predefined admission criteria of each programme of study. The general admission criteria are based on the type and quality of previous studies, the grade obtained in previous studies, and the suitability of the candidate for the requested programme of study.

Applicants must have completed a 6-year secondary education from a country which is recognized by the government of the Republic of Cyprus as being equivalent in terms of educational provision at secondary level.

- Applicants should have a very good knowledge of the English language and provide an accredited Certificate of English language proficiency (e.g. TOEFL, IELTS, GCSE).
- Applicants for the School of Architecture and Environmental Design must submit a visual portfolio of personal architectural and artistic work to assess their design/art abilities.
- Applicants for the Postgraduate programmes must submit a certified copy of their first undergraduate degree. The selection criteria will depend of the programme of study.

Admissions of Students with Special Needs

The University offers equal opportunities to all students regardless of their physical abilities. Candidates who have some form of disability which is mentioned in their application form will be examined on equal terms as all other candidates. They should explain in their application form the nature of their disability and inform the admissions office concerning the special needs they will require during their studies.

Application Forms

Application forms for undergraduate studies are available from the Course Office and, once completed, should be returned directly to that office, together with the additional documentation specified above and in the admissions criteria section of each programme. An electronic version of the undergraduate and postgraduate form and any other supplementary forms can be downloaded from the University's website. The selection criteria for the applicants who will be offered a place will be the School leaving certificate grades, the interview results, the reference letters and the results of any University entry examination, if taken.
