Dr. Artemis D. Savvidou is Member of the Teaching Staff of Law School in NEAPOLIS University, Paphos (Special Teaching Staff of Law School – Criminal Law) since September 2013. For the academic year 2013-2014 she was teaching "Practice of Criminal Law and Criminal Procedure", a course included in the 4<sup>th</sup> year of the Law school – compulsory (Cypriot Law specialization). From the academic year 2014 up until today (2018-2019 academic year): teaching self-reliantly the following subjects:

- 1. General Criminal Law CY: compulsory, 1st year of studies, Law School
- 2. Special Criminal Law CY: compulsory, 2<sup>nd</sup> year of studies, Law School
- 3. Criminal Procedure CY: compulsory, 3rd year of studies, Law School
- 4. Criminal Law and Criminal Procedure Practical Issues CY: compulsory, 4th year of studies, Law School
- 5. Criminology General: optional, 2<sup>nd</sup> year of studies, Law School
- 6. Foreigners and Immigration/ Immigration and Asylum Law General: optional, 3<sup>rd</sup> year of studies, Law School

For the academic year 2017-2018 was teaching Environmental Law (compulsory subject) for the MSc programme of the Architecture School: "Environmental Impacts Assessment and Sustainability Management" and for the academic year 2018-2019 was teaching on the online courses of NEAPOLIS University, as part of the subject "The pros and cons of the Cypriot Public Administration".

In September 1994 Dr. Savvidou succeeded in the Pancypriot entry exams (7th ranking) and in 1998 obtained a B.A. in Law, Economics and Political Sciences, National Kapodistrian University of Athens. In 1998 she successfully attended a seminar organized by the Law Department of the National and Kapodistrian University of Athens with the following subject: English Legal Terminology, 6 months duration. Similarly, in 1998 she successfully attended a seminar organized by the Law Department of the National and Kapodistrian University of Athens with the following subject: Legal Graphology, 6 months duration. In July, 6th, 1999, after a recommendation by the Minister of the Interior of the Republic of Cyprus, Mr. Ioannis Kassoulidis and the Minister of Justice and Public Order, Mr. Nikos Kossis, Dr. A. Savvidou enrolled in the Panteion University of Athens, where she attended a series of M.A. level courses dealing with the subject "Administration and Local Government". In 2014, she has submitted an application for conducting a Doctoral Dissertation at the Law Department of the Democritus University of Thrace on the field of Criminal and Criminology Studies, which has been accepted by a decision of the General Assembly of the Faculty Department by which Prof. St. Pavlou (as supervisor), Associate Prof. Symeonidis and Associate Prof. Dimitrainas (as members) have been appointed as counseling committee as provided by law. In 2018 the General Assembly of the Faculty Department appointed for the deven-member examination committee, besides the above-mentioned members, Associate Prof. Bekas, Associate Prof. Vathiotis, Assistant Prof. Tzortzis and Assistant Prof. Kosmatos. On September 6th 2018, after open oral examination, she was qualified as Doctor of Law in the Democritus University of Thrace, on the Criminal Law and Criminal Procedure subjects. Her thesis "The thief crime and its Procedural Treatment by the Criminal Law in Cyprus. An analytical approach in comparison to the Greek Criminal Law" was assessed as "EXCELLENT" unanimously by the serve-member committee.

Dr. A. Savvidou has practiced law in Kostas Tsiridis and Co as a trainee lawyer (1998) and as Lawyer (the license was acquired on 1999 from the Legal Council of Cyprus marked as "EXCELLENT"); as Self-employed and later working with DEMETRAKIS SAVVIDES & CO LLC directors with specialisation and long successful involvement in Criminal Law cases, Dr. A. Savvidou dealt with serious cases that concerned the Society and the Media of Cyprus. (1st degree murder, homicile, personal injuries, rapes, arsons and certainly cases that involve financial crime, thefts, robberies, corruption in Public services, Municipalities, communities and banking institutions, money laundering etc); as Accredited mediator (Justice Minister), after an announcement on the Official Journal and a relevant decision from the Justice and Public Order Ministry and the Police Chief, her name is included in the lecturer list of the Cyprus Police Academy for the following subjects/modules: Criminal Law and Criminal Procedure, Evidence, Criminology, Human Rights.

She is acting also as Legal Counselor in Companies (LLC) in Cyprus and abroad.

Dr. A. Savvidou demonstrates participation in Scientific Meetings and Seminars of short duration with chief executives of the European Union (organizer Learning, Research and Development Centre, Athens); attendance of various seminars of short duration on different matters (European, local facilities etc.) organized in Athens either from University Institutes or from various Scientific Journals; cooperation in times with the Drafting Group (as a member) of the twenty-year publishing scientific Rev. Dec. Loc. Gov. Reg. Dev. (with the peer review system) Athens; participation as a Project Coordinator in a Scientific Study of post-graduate students of the University of NEAPOLIS in Cyprus on matters of European interest; participation in Scientific events organized by different municipalities in Greece, University (Cyprus) etc.; Statement (of hers) on Scientific Event of the Municipality of Acharnes is included in a special issuance funded by the Niarchos Foundation. Also Dr. A. Savvidou has been selected by a committee consisted of University Professors, to participate in a series of Scientific Events in Brussels, with statements or observations, organized by various

European Union Services (European Parliament, Committee of the Regions, Economic and Social Committee etc.) on matters of European interest (2013-2014); has been member of the Scientific Committee for the evaluation of texts in scientific journals (Athens), a member in evaluation Committees on M.A. Theses of the Public Administration Department, NEAPOLIS University of Paphos and participated in Scientific Conferences organized by Universities and other Institutions in Cyprus and Abroad with statements in some of them.
