Neapolis University Pafos (NUP) is a fully recognised private University (www.nup.ac.cy) in the Republic of Cyprus, based in the city of Pafos.

The University announces one (1) position at the rank of **Professor** at any field of the **Science of Law**, which at this stage is open in order to facilitate the process by expanding the possibility for submitting an expression of interest.

For the rank of Professor, the following is required:

- (a) At least ten years of total University or equivalent employment after obtaining a doctoral degree, from which at least four years are university employment, or holding a position at the rank of Professor at a recognised University.
- (b) International recognition of scientific work, which is substantiated by the publication of articles in international scientific journals, or monographs, or books.
- (c) Supervision and successful completion of research programmes or doctoral dissertations.
- (d) International recognition of the candidate's contribution to a specific research field, such as research references, invitations to scientific lectures, assignment of article evaluations, research proposals or doctoral dissertations, participation in scientific journal publication committees, or participation in organising conferences.
- (e) Contribution to the promotion of the teaching and administrative work of the University.

Practical and proven knowledge of the operation of educational systems abroad, especially in an English-speaking country, as well as corresponding administrative experience at a University, will be seriously considered.

The University will offer an internationally competitive annual earnings package, based on the candidate's qualifications and experience.

The successful candidate is expected to be able to accomplish the following tasks:

1. Assumption of administrative duties.
2. Teaching a (limited) number of courses related to his/her discipline.
3. The academic and scientific supervision of all the programmes implemented by the Department of Law.
4. The active participation in the development of research programmes with the participation of the Faculty members of the Department, as well as the Associate Teaching Staff which is employed in the distance programmes of the Department.
5. Active participation in the development and accreditation of an English-language Undergraduate Study Programme.
6. Active participation in the development and accreditation of new English-language Postgraduate Study Programmes.
7. Active participation in the process of promoting programmes and recruiting students, especially from third countries (except Greece / Cyprus), always in collaboration with the International Marketing Department of the University.
8. The candidate must reside in the Paphos district.
9. Proficient command of Greek language will be considered an advantage.
