Candidates will maintain an active research agenda while teaching four sections per academic semester in this position. We focus on developing a good relationship with our students and to this end our sections are generally less than 40 students. The candidate will teach economics courses from within

the undergraduate and graduate courses offered <u>on campus in Pafos, Cyprus</u>. The candidate will also make a strong ongoing service contribution to the department, school, university, and/or the broader community.

### **Qualifications and Experience:**

The Department of Economics and Business at NUP seeks applicants to do research in the area of (applied) economics. Fields related to business economics are preferred but all fields of economics will be considered. A demonstrated strong potential for excellence in scholarly research and teaching is required. Applicants should normally have an earned doctorate in Economics. PhD candidates who are close to completion will also be considered. The position entails conducting research, teaching, and service.
